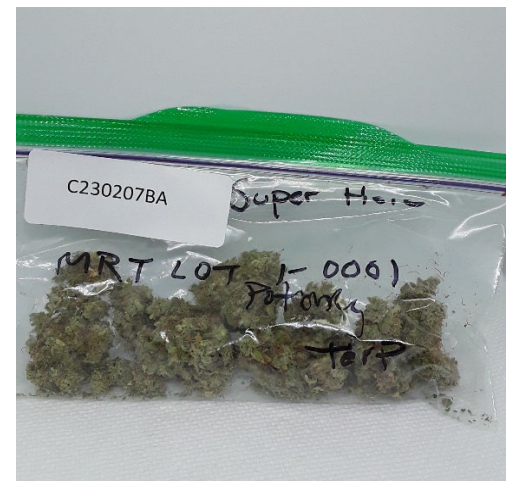


Reagent Blanks: < LOQs for all analytes
