Cannabinoids Methodology: High Performance Liquid Chromatography (HPLC) using PerkinElmer FLEXAR™ with Photo Diode Array Detector (PDA)

Total CBD and total THC are calculated values, to account for assumed decarboxylation from the acid-form (THCA or CBDA) to the neutral form, causing weight loss of the acid group. These values are calculated as follows:  
 Total THC = (THCA x 0.877) + Δ9-THC      Total CBD = (CBDA x 0.877) + CBD  
 Ratio of Total CBD: Total THC      Reagent Blanks: < LOQs for all analytes

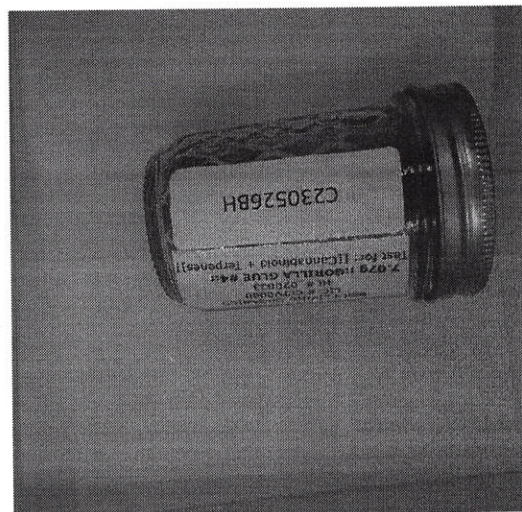
LOQ = The lowest quantity that this method can reliably detect. Any cannabinoid that was not detected is assumed to be less than the stated LOQ (<LOQ).

All results reflect dry weight of material, based on % moisture of the sample.

Measurement of Uncertainty (MU): the parameter, associated with the result of a measurement, that characterizes the dispersion of the values that could reasonably be attributed to the particular quantity subject to measurement.  
 Δ9-THC MU = ±0.005%      Total THC MU = ±0.007%

All other cannabinoid MU values are available upon request.

All moisture analysis is determined by loss-on-drying measurement using OHAUS Model MB90 Moisture Content Readers.
